Re: May Day Idaho Mine Complex

Dear Mr. West.

The Board of County Commissioners of La Plata County received the notice issued by the Colorado Division of Reclamation, Mining and Safety for the May Day Idaho Mine Complex permit amendment. After reviewing the permit application, a few discrepancies were noted as listed below:

- The application indicates a county driveway permit has already been obtained. The driveway permit that was issued will not cover mining operations and a new driveway permit is required.
- The application indicates a sanitation permit has been issued by La Plata County. Since the County does not issue sanitation permits, the applicant needs to obtain a permit for sanitary facilities from San Juan Basin Public Health.

La Plata County does have concerns that a hard rock mine may produce acid mine runoff and would like assurance that the stormwater management plan is sufficient to properly convey any runoff that is generated from precipitation or mine drainage. While we understand this mill will not contain a crusher and the mined rock will be processed off-site, containment of the mill tailings is an important aspect of handling mine waste and protecting surface water. La Plata County would prefer stockpiles be handled in such a manner to prevent any potential contamination from entering the soil or surface water.

The County has additional concerns regarding the proposal to reclaim the area to a recreation use. The application indicates the access roads will remain after the mine is closed. The high level of precipitation and steep slopes in the project area exacerbate erosion and stormwater impacts. If the access roads are left in place, there is potential for increased stormwater impacts to adjacent water ways and public use of non-maintained roads. This action may lead to further degradation of the area if left uncontrolled.

The proposed development is expected to have impacts on adjacent land owners due to noise from mining operations and traffic. Noise was a concern expressed previously by the neighbors in the proposed project area. Blasting, generators, or ATVs on the site have the potential to create noise impacts. The use of sound attenuation walls, mufflers, and other mitigation measures is preferable. Also, please be aware that ATV use is not allowed on the county road adjacent to the project site. The traffic associated with transporting ore offsite for processing is expected to impact neighbors as well as county road maintenance costs and safety. A road impact agreement may be required to address these impacts. Although the expected impacts to adjacent land owners and the County will be addressed through the county land use permit process, please be aware that these issues are of concern to the County.

The Board of County Commissioners appreciates the opportunity to comment on the proposed May Day Idaho Mine Complex permit amendment.

Mining ildcat Corp., which has had a long and troubled relationship with regulators, is under new management and has a new plan for its La Plata Canyon mines, this time possibly capitalizing on the country's demand for green energy.

But some residents near the mines who have been vocal opponents of Wildcat Mining remain skeptical.

"It's insane," said Scott Collignon, a property owner near the mines. "These guys have run wild for four years, and now we're going to do it all again.'

With new management and investors at the helm, Wildcat Mining this month submitted a new land-use permit application to La Plata County planners. The company hopes to reopen the historic May Day Idaho Mine Complex near Hesperus. New

I am writing concerning "Sunrise Mining's" application for amendment of Permit #M-1981-185(Mayday Idaho Mine Complex). I am assuming that those involved with this application at CDRMS are well acquainted with this "project"-previously referred to by various business names-but all in reference to the Mayday Mining complex near our homes in Mayday/Hesperus CO. Many of the main actors involved in previous CDRMS applications are still involved with the project-now under a new name. Those acquainted with the infamous history of this project will also be acquainted with the litany of violations that occurred at the mining site-leading to past "stop work" orders etc.

I suspect on some level CDMRS's patience has also been tried dealing with this project and the individuals involved-however, for those living near the mine, you may realize how frustrating it is to again learn that the Mayday mine is yet again being presented as a viable project despite the environmental insults and damage that this project has resulted in, not that long ago. It is like living under a tree that is destined to fall-leaving us to wonder what damage it will result in.

Is there no threshold that is reached where CDRMS says "Enough is enough"? After the Gold King disaster those in La Plata County wondered why was this not foreseeable? Now the residents of Mayday again have to watch the process play out in real time.

The Mayday project has been given "one more chance" more than once. I would ask CDRMS to not amend Sunrise's permit...and to watch and monitor all their activities with a magnified diligence. Their past history of stretching and disregarding many rules and regulations is entrenched in the methods of these individuals. Further, the required mitigations ordered by CDRMS should be completed in their entirety before any adjustments or amendments are considered.

The La Plata River runs directly below this proposed mine site. We all know what happened in Silverton with the Animas River disaster and having the La Plata vulnerable to the same pollution is another setting for disaster.
