Gentlemen:

On May 12, 2017 DRMS issued a letter to Lance Baller of High Speed Mining, LLC requiring them to demonstrate compliance with Park County planning Department (regarding illegal mining a residential zone) within 60 days.

To date, there is NO evidence of any documentation in the mine file demonstrating such compliance.

In fact, no such documentation exists because to become compliant, the property presently zoned residential would have to be re-zoned to mining. This has not occurred.

Thus, High Speed Mining is in violation of C.R.S. 34-32.5-115(4).

This mine needs to be shut down. It continues to operate to the detriment of nearby property owners and the general public who must put up with the noise, dust, and other issues associated with the illegal activity.

I trust DRMS will do the right thing. And soon.

I hereby file a formal complaint against mine M1991037 Katuska Pit/High Speed Mining .

This mine is operating without approved/signed satisfactory completion of Administrative Review of Mining Activities by Park County Planning Department.

This has been verified with Park County Planning Department in documents provided to me under the Colorado Open Records Act.

This is a violation of Park County land use regulations, as well as Colorado statutes requiring all mines to maintain compliance with all applicable local laws regulations and ordinances.

Thus, High Speed Mining is in violation of C.R.S. 34-32.5-115(4).

A similar complaint will be filed with Park County.
