Dear Ms. Burt:

The Teller County Planning Department has completed its review of the Department of Reclamation, Mining and Safety (DRMS) required Technical Revision (TR-93), that proposes the construction of approximately 1,100 feet of Type 3 guardrail along CR 82.

Teller County understands that CC&V submitted TR-93 to the Division of Reclamation, Mining and Safety (DRMS) on July 31, 2017. The Director of the Community Development Services Department (Department) and the Teller County Planner also discussed this TR with Ms. Clara Steward, CC&V [Senior Environmental Coordinator, sustainability and External Relations] on July 31, 2017] via telephone.

It is further understood that this TR is in response to one of the conditions imposed on CC&V as part of the Department of Reclamation Mine Safety (DRMS) conditional approval of Amendment 11. It is our understanding from the July 31, 2017 conversation with Ms. Clara Steward that CC&V personnel have been in direct coordination with Mr. Bryan Kincaid, the Teller County Rights-of-Way Supervisor, and the installation of the guardrail will meet all of the guidelines and specifications of the Teller County Roadway design criteria and regulations.


We are aware that that your chosen contractor [Tezak Heavy Equipment] has produced a design that complies with all Teller County regulations and specifications for the 1,100-foot guardrail and that once this TR is approved by DRMS, you will begin immediately.

Teller County has no objections to the construction of the 1,100-foot guardrail as directed by DRMS and concurs that it is a No Impact Technical Revision that will serve a safety function for the public good

Please insure that all necessary Teller County permits are applied for, Mr. Bryan Kincaid is kept apprised of your construction schedule, and the Teller County Standards for Roadway Design with regards to the actual installation of the guardrail are met.

Thank you for the opportunity to review TR 93.
