Hello Wendi,

Responding to your voicemail regarding if two companies are allowed to mine, crush, sell out of one permit and if so what is required from the state:

• Once a permit has been issued, a permittee can choose to have different operators, contractors, subcontractor ect. on site to do various work. The Division does not require any submittals nor information regarding these other individuals working at the site. The permittee is still responsible for ensuring all activity occurring at the site is in compliance with the approved permit, Act, and Rules and Regulations of the Mined Land Reclamation Board. The permittee is also responsible for any non compliance issues as wells as the the reclamation liability at the site.

SUBJECT: Complaint: Hauling water from Evans #2 Pit to State Pit

Jodi, in response to a complaint received regarding Fremont Paving and Ready Mix hauling water for dust suppression from the Evans #2 Pit to the State Pit, DWR conducted investigations into the situation and we have the following requirements.

The Evans Pit is also known as the Pueblo East Pit at Evans #2 and is covered under DRMS file No. M-2000-041 with a Substitute Water Supply Plan (SWSP) under ID 5732 most recently approved April 21th, 2017. The SWSP is approved under Section 37-90-137(11), C.R.S for a sand and gravel pit and issued well permit no. 54064-F, WDID 1406561. This Evans #2 Pit SWSP approval limits the uses under the SWSP to the location of the DRMS permit. Additionally, the State pit does not fit the criteria of Section 37-90-137(11), C.R.S. in that the State pit is not a (1) sand and gravel operation that is (2) permitted by DRMS with (3) exposed ground water and would not qualify for its own SWSP under Section 37-90-137(11), C.R.S. Therefore, hauling water to the State pit from the structures approved in the Evans #2 Pit SWSP is not allowed.

In our phone conversation July 6th, 2017, it was stated that Fremont Paving has discontinued hauling water from Evans #2 Pit to the State Pit. Fremont Paving still has a need for dust suppression at the State Pit, and it was also stated that Fremont Paving has contracted with St. Charles Mesa WD for bulk water purchase from their municipal water system. This bulk water purchase is hauled to the State pit for the dust suppression uses.

Based on the facts that water is no longer being hauled from Evans #2 pit and that water is purchased from a municipal provider for use at the State Pit; the issues identified by hauling water from Evans #2 outside the SWSP approval have been discontinued. Therefore, there are no further issues from this complaint that need a remedy at this time.
