Dear Mr. Forrest,

The Division of Reclamation, Mining, and Safety (Division) has reviewed the content of your 110(2) Limited Impact Operation Reclamation Permit Application and Adequacy Review Responses for the Forrest Mining Project, File No. M-2017-012, and submits the following additional comments. **The Division is required to make an approval or denial decision no later than <u>January 3, 2018</u>. Please respond to this Adequacy Review with a letter summarizing each response, to the numbered items below, in a cover letter titled "Adequacy Review Response #2; M-2017-012".**

The review consisted of comparing the application content with specific requirements of Rules 1, 3, 6.1, 6.2, and 6.3 of the Mineral Rules and Regulations of the Colorado Mined Land Reclamation Board for Hard Rock/ Metal, and Designated Mining Operations. Any inadequacies are identified under the respective exhibit heading.

6.3 SPECIFIC PERMIT APPLICATION EXHIBIT REQUIREMENTS –110 LIMITED OPERATIONS

EXHIBIT C - Mining Plan (Rule 6.3.3)

25. Within the response to Adequacy Item 10, the proposed excavations will not exceed 20 feet in depth. In lieu of engineering stability analyses for proposed mining slopes, as required by Rule 6.5(2), please commit to maintaining a 3H:1V ratio for distance from the permit boundary to depth of excavation (i.e an excavation of 20 feet should be no closer to the permit boundary than 60 feet). This commitment will help ensure protection of off-site lands in accordance with C.R.S. 34-32-116(7)(h). Please note, as mining progresses, the Applicant may submit a Technical Revision to the permit addressing slope stability analyses to allow excavations near the permit boundary.

EXHIBIT D - Reclamation Plan (Rule 6.3.4)

26. The Division has reviewed the reclamation cost estimate provided in Exhibit D. The Division has accepted this reclamation cost estimate and the financial warranty will be set a \$13,480.00 upon permit approval. The Forest Service has concurred with this cost estimate as well. *No further response needed.*
