RE: Approval of SL-10 Phase III Bond Release, Roadside Portals Mine, Permit No. C-1981-041

Dear Mr. Boulay,

This letter acknowledges the Office of Surface Mining Reclamation and Enforcement (OSMRE), Denver Field Branch (DFB) receipt and review of the above Phase III Bond Release Proposed Decision document prepared by the Division of Reclamation Mining and Safety (DRMS) dated Jul 26, 2016. The Proposed Decision documents the applicant's compliance with the approved Colorado regulatory program at Rule 3.03.2.

DRMS's proposed decision approves 4.0 acres of Phase III bond release. This bond release applies to portions of the Roadside Mine northeast of Palisade, Colorado. OSMRE participated in the bond release inspection held on April 24, 2017. The Bureau of Land Management (BLM) also participated in the inspection. By letter dated August 10, 2017, the BLM provided its concurrence with the SL-10 bond release (attached). OSMRE interprets the BLM's concurrence to mean the Roadside Mine is in compliance with all BLM coal lease stipulations.

OSMRE agrees with DRMS that Snowcap Coal Company, Inc. has met or exceeded the requirements for Phase III bond release on the specified 4.0 acres of land as described in DRMS Proposed Decision document. The Division currently holds a performance bond in the amount of \$805,952.60 for the Roadside Mine, with a liability of \$79,791.40. DRMS proposes to release \$14,089.16 of liability with this bond release action (\$4,733.13 less than the amount Snowcap Coal Company requested) revising the liability down to \$65,702.24. OSMRE agrees with the findings and decision document and hereby provides concurrence for the above bond release action in accordance with 30 CFR 740.15 (d) (3), and 30 CFR 906.30, Article IX, Section 24, of the State-Federal Cooperative Agreement.

Subject: Roadside Portals Mine (C-1981-041) Bond Release Application No. 10 (SL-10)

Snowcap Coal Company, Inc. (SCC) applied to the Colorado Division of Reclamation, Mining, and Safety (CDRMS) for partial Phase III bond release (SL-10) on 4.0 acres of their Roadside Portals project. The Roadside Portals project is located in Mesa County, approximately three miles northeast of Palisade, Colorado. The SL-10 application was received by DRMS on March 10, 2017. It was deemed complete on April 6, 2017. SCC notified the public, all interested parties, and all interested government agencies. A bond release inspection was conducted on April 24, 2017 by CDRMS, BLM, and the Office of Surface Mining, Reclamation, and Enforcement.

GJFO has reviewed the bond release application No. 10 for the Roadside Portals project and **concurs** with the CDRMS decision to partially release bonding related to Phase III reclamation of the 4.0 acres. This will reduce the current liability by \$14,089.16, leaving a remainder of **\$65,702.24**. 11.0 acres of disturbance are currently still covered by the remaining liability. The specific area of the proposed bond release request applies to:
