Kym Schure ("Permittee"), who holds DRMS mining permit number M-1986-074, submitted an "Application for Technical Revision" to that permit on August 16, 2017. The Division responded with an adequacy review letter dated August 28, 2017, stating that the Technical Revision failed to demonstrate a legal right to enter to perform reclamation on Tract 6, and therefore cannot be approved as submitted.
