Second Quarter 2017 Pond Inspection Report Review

The Colorado Division of Reclamation, Mining, and Safety (CDRMS) has reviewed and found the above referenced report to be in compliance with the following CDRMS regulation(s):

4.05.9(17) - Examined at least quarterly by a qualified person designated by the operator, for appearance of structural weakness and other hazardous conditions.

4.05.9(17) - A copy of the report shall be submitted to the Division on a quarterly basis.

The second quarter pond inspection report was received by the Division on August 1, 2017. Pond inspections were conducted by Scott Wanstedt of BME on June 22 and 30, 2017.

It is noted that discharge was only observed from the DP-1 pond, raw water lagoon, and the B-Seam dewatering ponds. The Division understands that, based on the information in the report, seepage at the SDH-3U process pond was observed. It is noted that during the Division's August 2017 coal partial inspection, seepage at the BD-2 dewatering pond #5 was observed. This area should continued to be monitored to ensure that the integrity of the pond is not compromised.

Longwall mining did not occur under RCR #65 during the quarter. Only superficial surface impacts from prior mining was observed and no significant damage that would warrant repairs.
