Drill holes N1, N2, N3, E1, E2, E3, and E4 with associated access disturbances were reclaimed as required per X-2008-230-02.

Drill holes E5 and all WR-x holes were not drill and no disturbances occurred related to these proposed holes. We will not be drilling/disturbing these sites under this NOI.

These areas happened to be in areas dominated by cheatgrass with limited reclamation potential. However, the resulting reclamation is as good or better than the adjacent undisturbed lands.

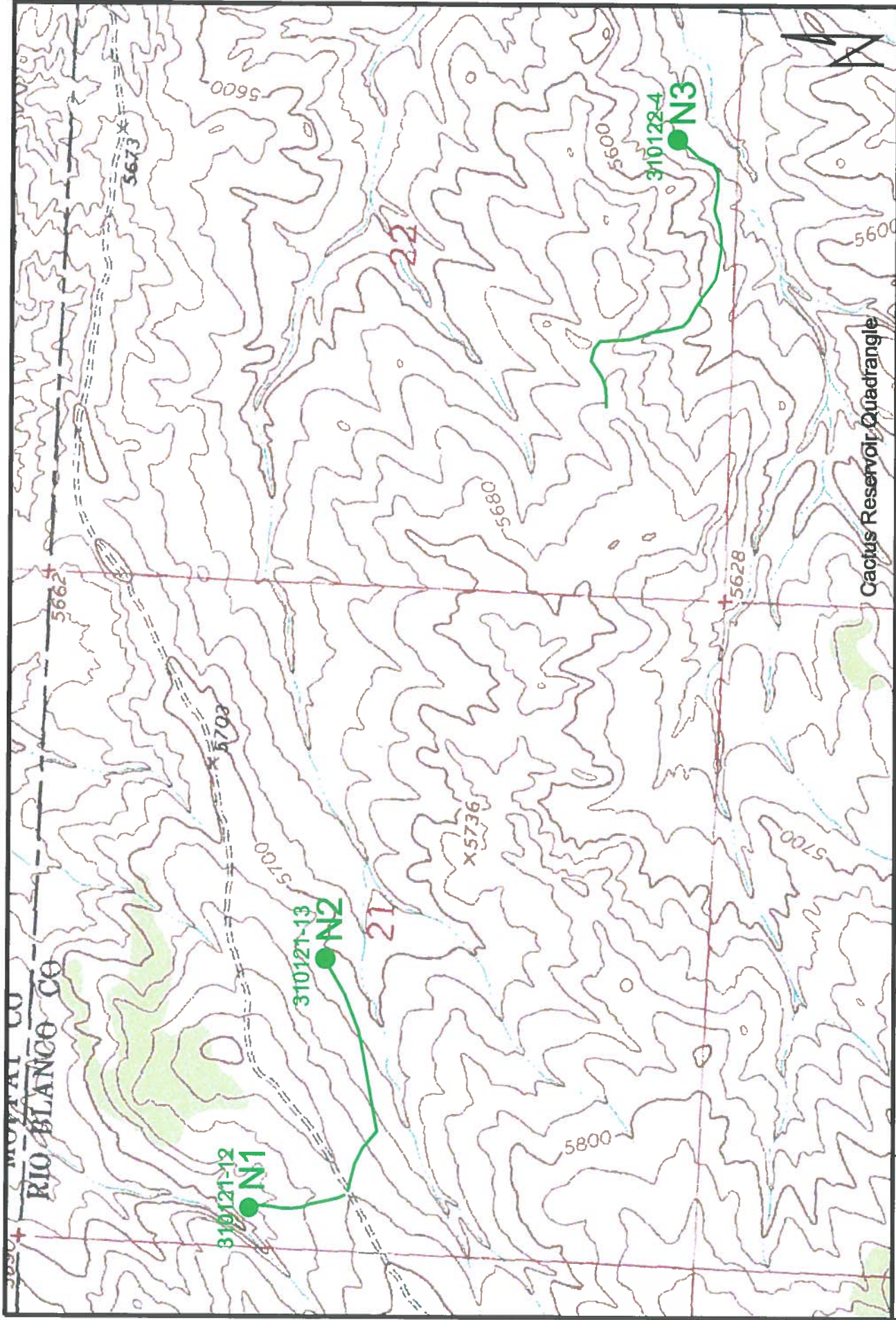
