On September 6, 2017 Tara Schutter, PE from Tessara Water, LLC. contacted you on behalf of Adams County, Todd Creek Village Metropolitan District (TCVMD) and South Adams County Water and Sanitation District (SACWSD) in regards to a request for a Technical Revision (TR) relative to M-1982-147 Nyholt Pit (aka Mann).

Adams County Parks and Open Space has partnered with TCVMD and SACWSD through an Intergovernmental Agreement (IGA) in order to make certain improvements to the mining area in preparation for its intended use as water storage as well as the future expansion of the Regional Park and Fairgrounds. Specifically this TR request is for the installation of a *French Drain System* designed to alleviate ground water pressure on the already approved clay liners. The drain will be approximately 300 feet long and installed to a depth approximately 21 feet below grade.
