As previously discussed, it has come to the attention of the Division of Reclamation, Mining and Safety (Division) that the assigned annual fee for the Ace in the Hole- CMC284074, Permit No. M-2013-056, is incorrect. When the permit was issued, an incorrect annual fee amount was set. Pursuant to C.R.S 34-32-127(2)(IV)(B), the annual fee for a 110(2) operation is \$259.00. The Division sincerely apologizes for this inconvenience and in order to correct the situation, is returning the recent 2017 annual fee submitted on September 7, 2017. **Please re-submit your 2017 annual fee in the amount of \$201.00** on or before **October 9, 2017**.
