Dear Mr. Abrams:

On September 6, 2017 the Division of Reclamation, Mining and Safety (Division) received your application to modify (MD-01) your Notice of Intent to Conduct Prospecting Operations (NOI). The Division has reviewed the NOI application for deficiencies. Please address the following items:

Application:

- 1. Only Form 2 (Public file) was submitted. Please confirm there is no confidential information in the NOI modification application.
- 2. <u>Item 3, Company Name</u> The company name on the NOI modification application must be exactly the same as that registered with the Colorado Secretary of State and that under which the original NOI was filed. Our records show the company name is: Viscount Colorado Holdings, LTD. Please correct the cover page of the modification application, both under "Prospector" and "Person MLRB Should Contact" and resubmit this page.
- 3. <u>Item 5, p. 3, UTM coordinates</u> The coordinates given appear to be reversed for latitude and longitude and the number provided as latitude (which is assumed to be the longitude) has one too many decimal places. Please review and correct theses coordinates.
- 4. Part II, Maps and Drawings, p. 5 As stated in the application from under part II maps and drawings, "An accurate topographic base map showing the location of the proposed project must be submitted with this notice." No map was included with the modification application. Please review the requirements for the required map stated in this portion of the application and submit the required map.

Financial Warranty:

Please note the Division will estimate a cost to reclaim the site based on the application and your response to the deficiencies described above. The financial warranty may or may not exceed \$2,000 per acre of affected land depending on the Division cost estimate. Please be reminded that the proposed prospecting operations identified in the current modification application may not commence until these deficiencies are addressed and the bond is submitted and approved by the Division.

Pursuant to Rule 5.1.3(c), the above deficiencies are required to be addressed within 60 days of this notice or the Division may deny the modification application. Please be advised the Viscount Colorado Holdings Ltd Prospecting Modification Application may be deemed deficient and the application may be denied on November 17, 2017 unless the abovementioned deficiencies are addressed to the satisfaction of the Division.
