OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. Russ Means and Lucas West (DRMS); Ed Cotter, Kyle Turley, Bill Dam, Jim Denier, and Polly Robinson (DOE); Gus Gaviotis and Scott Pottorfs (Cotter Corportation) were present. Photographs are included with this report in order to illustrate some of the conditions observed.

The JD-7 Pit is located approximately ten miles west of Naturita and accessed from EE17 Road. The site is a 112d-3 operation that includes a total of 504 permitted acres.

Adequate mine identification signage was noted at the entrance to the site.

No recent mining activity has occurred at the site. Activity has been limited to minimal site maintenance and housekeeping. The site is used as a hub of operations for Cotter's other permitted sites in the area. Equipment stored on site is orderly. The pit floor and dump area appear well vegetated and stable. No stability issues were noted with the pit highwall.

There was a small sinkhole forming on the west side of the parking area near the shop. This will need to be filled in and repaired. A small amount of knapweed was observed along the slope and drainage near the treatment ponds. This will need to be treated as soon as possible.

No other problems or violations were noted during this inspection.
