Elk Ridge Mining and Reclamation, LLC, P.O. Box 628, Nuclea, CO 81424 has filed with the Division of Reclamation, Mining and Safety an application for Technical Revision No. 82 (TR-82) to the New Horizon Mine Permit No. C-1981-008. TR-82 proposes to add 0.42 acres of adjacent support facilities area to the permit to facilitate maintenance of topsoil piles 11A & 11B on Slash M. LLC property.

The New Horizon Mine office is located at 27646 West 5th Street, P.O. Box 628, Nuclea, Colorado. The permit area contains tracts of land located in Section 6, Township 46 North, Range 15 West, Section 31, Township 47 North, Range 15 West, Section 1 Township 46 North, Range 16 West, Section 36 Township 47 North, Range 16 West, of the New Mexico Principal Meridian, Montrose County, Colorado. The above mentioned tracts of land are shown on USGS 7.5 minute Nuclea Quadrangle map.
