Elk Ridge Mining and Reclamation, LLC, P.O. Box 628, Nuclea, CO 81424 has filed with the Division of Reclamation, Mining and Safety an application for a Technical Revision 81 (TR-81) to the New Horizon Mine Permit No. C-1981-008. TR-81 redesignates the 5th Street Light Use Road to the Lincoln Street Haul Road, identifies a coal storage area within the existing mine facilities area, and incorporates the most recent air permit approval into the permit application.

The New Horizon Mine office is located at 27646 West 5th Street, P.O. Box 628, Nuclea, Colorado. The permit area contains tracts of land located in Section 6, Township 46 North, Range 15 West, Section 31, Township 47 North, Range 15 West, Section 1 Township 46 North, Range 16 West, Section 36 Township 47 North, Range 16 West, of the New Mexico Principal Meridian, Montrose County, Colorado. The above mentioned tracts of land are shown on USGS 7.5 minute Nuclea Quadrangle map.
