Jerry,

I wanted to check the status of the proof of publication search with the Steamboat Pilot. If it appears that the notice was not published and a proof of publication can not be recovered, a new notice of completeness will be required to be published. As such, a new proposed decision date will be required. The current proposed decision date is November 10, 2017. If a new publication is required it must run for 4 consecutive weeks and require a 30-day comment period from the last publication.
