This is regarding the application for Loveland ready mix proposed site in Laporte Colorado.

I live the closest to the proposed site, less than 200 feet away. I have received their structural agreement letter, & have read the proposal. But my property, animals, & I are not the only ones that would be greatly affected by this plan. This proposal isn't just near the town of Laporte, it is in the town of Laporte, it isn't just near a residential neighborhood, it is surrounded by our neighborhood. Yes I live on the edge of my subdivision, but it is less than 200 yards away from where my neighbor's where their children play. Across from me lives my Mom, & brother, they moved here 15+ years ago after my dad died, so that they could be closer to my sister, & her family, but still live in a safe, quiet area because you see my brother has Autisum. Noise, stress, and sensory overload cause him to have "meltdowns", he screams, hits himself, breaks things on his head, legs his face sometimes. He throws things, & punches things. But he also has more subtle reactions to things, he scratches his skin on his arms, & face until he bleeds, when he was a child he plucked all of his eyelashes, & all of his eyebrow hairs out as a result of stress. He also has PTSD, & he isn't the only one, we have many vets who live here with PTSD too. People who served our country, in combat situations who moved here for the peace & quiet. How do you think the noise from this mining, & crushing of the proposal might affect them. There are also other vets like myself who have other health problems who are affected be air quality, due to things like asthma, fibromyalgia, that is affected by stress, & fatigue, who need quiet, who need rest. How do you think the dust, & noise will effect that, I moved here for quiet, fresh air, & peace, but also so that I could be near family, & health care providers, when I have flares I become weak, I have no energy, or strength, & I need rest, or I feel even worse, I have problems thinking clearly, and this just snowballs. I know this will generate revenue, provide jobs, & so on. And I know the materials produced are needed. But is this the only place in Northern Colorado where this can be mined? Does it have to be in a neighborhood? There is a lot of vacant land farther north, & east of our community, & our homes. Would you want this to be in Your Backyard?
