Hi Nicole,

I'm trying to finalize the inspection report for my inspection. There are a few items I need to follow up with you:

- 1) Tamerisk Control. On July 25th we had some back and forth emails addressing control of the Salt Cedar (tamarisk) at the Fountain Colony Pit. Your final email requested what documentation the Division would accept for demonstrating you

had started the required control program. I replied by stating "sending us a copy of their [TP Enterprises Inc. ?] itemized bill will suffice for our records. We'll also need the bill for cutting 2 years down the road." to date, I have not seen any documentation demonstrating you sprayed the tamarisk/salt cedar. If you can send me that documentation, I can close out the initial treatment portion of the corrective action.

2) Concrete pads: During the inspection, we discussed the concrete pads for the batch plant that was approved in technical revision #2 (TR-02). You thought at the time, the concrete pads were still there but had been covered up with pit run material. You said you would double check. Have you had a chance to double check on that? If they have been removed, can you provide the Division with a receipt if performed by a contractor, or a work order (or something similar) if done by Kiewit?

3) Topsoil: During the inspection we had some discussion as to whether any more topsoil was stockpiled and if it had been spread on the pit floor. I meant to follow-up earlier. Have you received any clarification on topsoil stockpiles and placement?

4) Annual Report: The Division is moving the responsibility for following up on annual report discrepancies to the specialists (like me). Our records indicate no map was sent with the 2017 annual report. This is required by statute (C.R.S. 34-32.5-116(3)(a)). I will try to contact Daniel Leone this week to discuss with him, but it will be listed in the inspection report if I don't receive the required map.

Please let me know if you have any questions.
