Ms. Eschberger,

As a property owner in the Southwest Highway 115 area, I object to Transit Mix Concrete Company's (TM's) application M2017-049 to establish a quarry on Hitch Rack Ranch.

The application jeopardizes the water resources of local residents, fails to protect the wildlife habitat which are being slaughtered daily due to traffic/truck overload on HWY 115, and violates the easement rights of property owners along Little Turkey Creek Road. I urge the Mine Land Reclamation Board (MLRB) to deny TM's application. Highway 115 is one of the most dangerous roads in the state and I fear it getting worse with the amount of trucks TM sends daily. At my home turn MM-36 there have been 3 accidents in one week due to traffic overload and speed and this was during calm weather!

I request that both the Pre-hearing Conference and MLRB Hearing be conducted in Colorado Springs.
