## RE: Mid-Continent LST, Permit No. M-1982-121, Administrative Revision (AD-1), Documentation Received-Maps and Acreage Issue

Dear Mr. Dangler:

On December 29, 2017 the Colorado Division of Reclamation, Mining and Safety (Division) received your Quarry Boundary and Survey letter submitted by Bobby Wagner on behalf of Rocky Mountain Resources (RMR). This was to address issues and commitments identified on the Division's letter sent on January 17, 2017.

In your response you have identified the following:

- The affected area outside of the mining permit boundary is 0.287 acres
- The calculated area of the approved AM-2 boundary is 38 acres
- The calculated area of the total affected land to date is 20.8 acres

In the letter RMR also proposed three solutions to resolve the boundary issue. The Division accepts all three solutions with slight modifications. RMR shall do the following:

- 1. Recreate the survey points for the 38 acre permit boundary which includes the 0.287 acre area which was previously out of bounds. Provide the Division with a table of the point data.
- 2. Adjust the recorded area of the AM-2 boundary to 38 acres, which includes the 0.287 acre area which was previously out of bounds.
- 3. Survey and install visible boundary markers, in the field for the accepted 38 acre permit boundary.

Additionally the Division requests the following:

- In a narrative
  - Clarify if the 0.287 acres outside of the permit boundary is included in the 20.8 acre of affected land to date. If not please state the affected land to date.
  - State the affected land acreage over the life of the mine.
  - Clarify the maximum disturbance at any given time



- In map form
  - Provide the Division with an updated location map, mining plan maps and reclamation plan maps
    - Maps must meet the requirements of Rule 6.2(2), 6.3.1 Rule 6.4.3 and Rule 6.4.6 respectively
  - Depict permit boundary as 38 acres which includes the 0.287 acre area.
  - Make the permit boundary line more visible on the satellite imagery maps.
- Notify the Division in writing when permit boundary markers have been place/moved to delineate the approved 38 acre boundary.

The above mentioned shall be received in the Division's Denver office by Friday. March 09, 2018.

These changes will be done under an administrative revision (AD-1) to the file. If the operator would like to make additional changes to the permit this will need to be done in the form of a Technical Revision or Amendment.
