Please be advised that on December 26, 2017, The Turquoise Connection, Inc., whose address and telephone number are 107 Wild Rose Dr., Cañon City, CO 81212; 719-557-2846, filed an Amendment application to the above-named permit. The operation is located at or near Section 13, Township 15S, Range 70W, 6th Principle Meridian, in Teller County. Please be advised that the permit area may be located in more than one Section, Township, and Range. Affected lands will be reclaimed to support a Rangeland post-mining land use. The application decision date is scheduled for January 25, 2018.
