## **OBSERVATIONS**

This inspection was conducted by the Colorado Division of Reclamation, Mining and Safety (Division) as part of the routine inspection program. The Natural Soda LLC Nahcolite Project is a 112d3 mine site that consists of 8,223 acres. Kirk Daehling of Natural Soda was present during the inspection.

On Tuesday January 2, 2018 the operator informed the inspector that there was a release of material on December 29, 2017 due to a valve failure. The spill was cleaned up prior to the January 4, 2018 inspection. The operator stated that approximately 200 gallons of baron liquor spilled during the undesirable event. The Division considers this matter resolved and no further action is required by the operator.

No off-site damage was observed during the inspection.

No problems or possible violations were observed during the inspection.
