PUBLIC NOTICE

Mountain Coal Company, LLC (MCC), 5174 Highway 133, Somerset, CO 81434, (970) 929-5015, has filed a complete application for Technical Revision No. TR-144 to MCC's Mining and Reclamation Permit No. C-1980-007 with the Colorado Mined Land

Reclamation Board (Board), under the provisions of the Colorado Surface Coal Mining Reclamation Act of 1979. The permit was originally issued by the Board in July 1981, and subsequently renewed in August 1986, January 1993 (effective August 1991), July 1996, July 2001, April 2007 (effective July 2006), and November 2011 (effective July 2011.) MCC is currently undergoing a five-year per-mit renewal process that would extend the permit term to July 31, 2021. The West Elk Mine five-year permit area contains lands in Sections 9-11, 13-36, T13S, R90W, 6th PM; and Sections 23-26, T135, R91W, 6th PM, and Sections 1-5, 8-12, T14S, R90W, 6th PM in Delta and Gunnison Counties. The location of the lands can be found on the USGS 7.5 minute Somerset and Minnesota Pass Quadrangle Topographic Maps. The current permit area encompasses approximately 17,234.9 acres.

This Technical Revision outlines an area south of existing long-wall panel LWE8 within the current lease and permit boundaries where MCC intends to conduct in-mine exploration activities to better define the influence of a projected fault zone within that area for future mine planning and permitting. Portions of MCC's permit document will also be updated with details of the recently modified federal coal leases. No surface disturbing activities are proposed with this application.
