

Compliance of Corrective Action stated in correspondence received by Operator (Kym Schure) in update letter from DRMS on December 21, 2017.

“Corrective Actions”

A. Response:

Operator has not been successful in acquiring a legal right to enter and conduct mining and/or reclamation operations on the 2.89-acre area where the surface is owned by Deborah Hradecky/Clark or her successor;

Compliance: Mr. Schure is submitting in this certified mail response in accordance with Rule 4.17 a partial acreage reduction request, surety (bond) reduction and revised estimate of the costs to reclaim the site w/unit costs for reclamation activities as appropriate to the operation to comply with Rule 3.1 and the Permit’s approved Reclamation Plan. Map illustrating the 2.89 acres reduced by the Operator and located upon property owned by Deborah Hradecky/Clark.

B. Response:

No legal right to enter said property in accordance with Rule 6.4.14 has been acquired by the Operator from the land-owner in the effort to resolve this dispute.

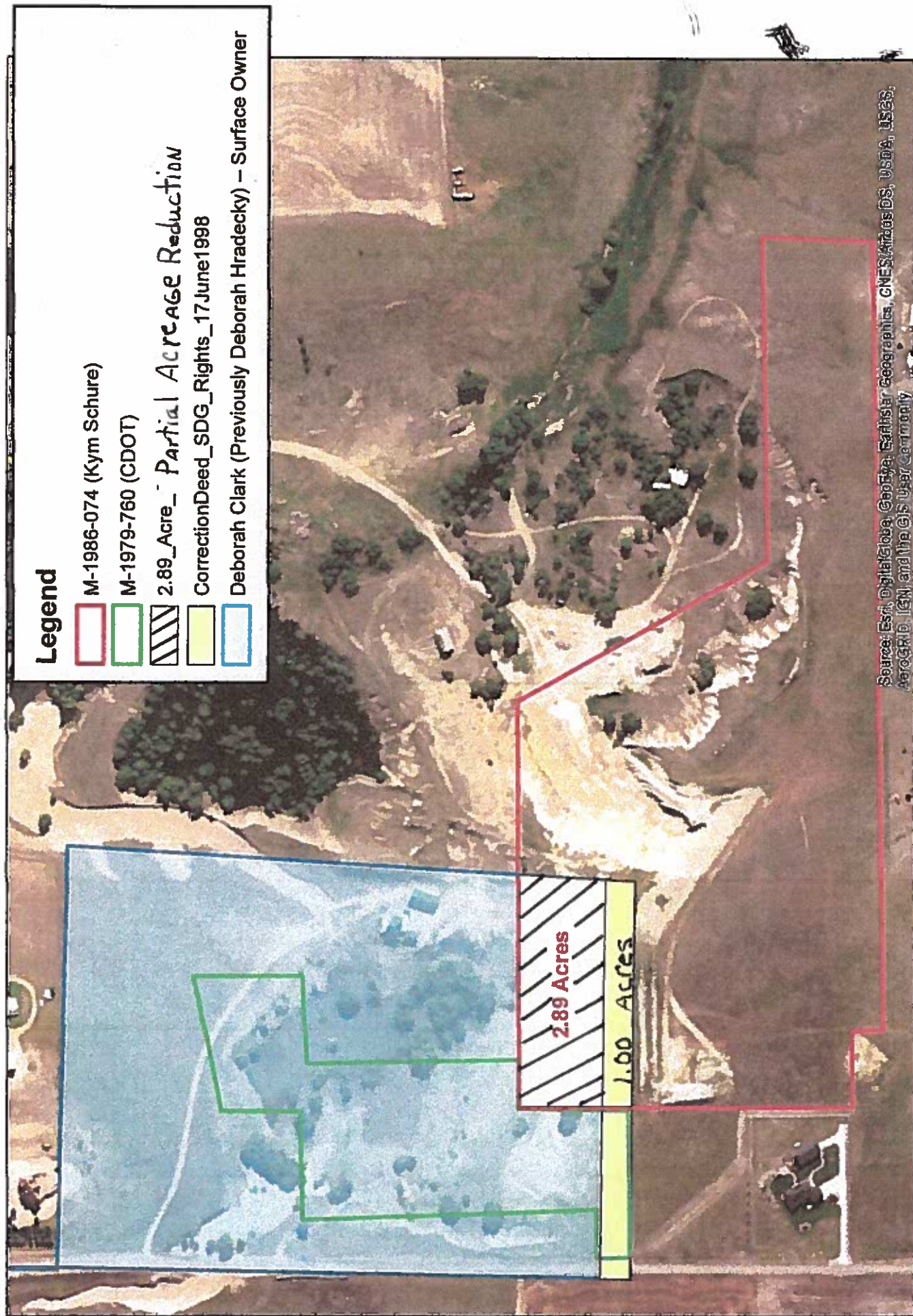
