Re: Request for Clarification of Procedures for Exchange of Exhibits in Transit Mix Concrete Co.,
Hitch Rack Ranch Quarry, File No. M-2017-049

Dear Mr. Graves:

Transit Mix Concrete Co. ("Transit Mix") requests clarification of the procedures related to the exchange of exhibits at the Pre-Hearing Conference in the above-referenced matter.

First, it would be helpful if you could confirm that PowerPoint presentations, Prezi presentations, or similar presentations ("Presentations") to be used at the Formal Hearing are "materials to be used as exhibits," as described in Rule 2.6(b)(i). Therefore, each party would provide copies of its Presentations to all parties and the Division at the Pre-Hearing Conference. Presentations often use charts, figures, photographs and maps that are not in the public files of the Division, and thus function as exhibits at the formal hearing. Presentations are also part of the administrative record of the formal hearing.

Alternatively, the parties could produce such charts, figures, photographs and maps at the Pre-Hearing Conference. In other words, any non-text image – that is, not just words on a slide – that will be used in a Presentation should be produced at the Pre-Hearing Conference. Our concern is that, absent this clarification, a party may present a demonstrative exhibit in a Presentation at the Formal Hearing that has not been disclosed as required by Rule 2.6(b)(i).

Second, we wish to clarify the process applicable to the exchange of exhibits at the Pre-Hearing Conference. As we read the "Order Regarding Deadlines for Service of Motions, Witness and Exhibit Lists, and Exhibits," the process is as follows:

1. File five hard copies of exhibits with the Board.
2. File all exhibits electronically with the Board and Division by emailing the exhibits to the Division at drms.temp@state.co.us.

3. Because filings are to be "made by the close of business on the day they are due," such electronic filings of exhibits therefore must be made by close of business on the day of the Pre-Hearing Conference, April 9, 2018.

Please confirm that we properly understand the instructions in the Order Regarding Deadlines for Service of Motions, Witness and Exhibit Lists, and Exhibits. If our understanding is incorrect, please let us know how best to make exhibits available to all parties.

We will distribute a copy of this letter by email to all interested parties to the best of our ability, using the email lists available in the Division public records. We would also welcome the posting of this request for clarification on the Division's Laserfiche system to allow for the solicitation of further comment on the procedural questions set forth above.

Thank you for your assistance in this process.
