### **OBSERVATIONS**

This inspection was conducted as part of the normal monitoring program for permitted Designated Mining Operations established by the Colorado Division of Reclamation, Mining and Safety. The Topaz mine is a 112d-3 operation that is currently in Temporary Cessation and consists of a maximum allowed disturbance of 30 acres. The period of Temporary Cessation was effective as of April 19, 2015 and expires on April 19, 2020. The site is a part of a five site permitted complex collectively referred to as the Sunday Mine Complex. The Division currently holds \$94,791.00 in Financial Warranty for the site. A reclamation cost estimate update was performed and staff calculations found that the currently held financial warranty is not sufficient to achieve reclamation in accordance with the approved reclamation plan. Please see the enclosed Notice of Surety Increase SI-3 and Reclamation Cost Estimate Worksheets for details. Four Photos accompany this report to illustrate the current conditions of the site.

As seen in Photo One, the permit ID sign was observed near the entrance to the site. The permit boundary markers were also observed. Evidence that the diversion ditches and storm water control devices are functioning as designed and no significant erosion was observed throughout the site.

All work and shop facilities onsite were secured and appeared to be in good condition. The portal located on site was also secured, it has been backfilled, closed off with steel grates as well as encompassed by a small berm as seen in Photo Two. Some mining related equipment including vent tubing and steel scaffolding is being stored on site. The items that are stored are in a neat and orderly fashion and not considered a problem at this time. No fuel storage containers were observed on site. Various other debris was observed on site however it was stored in an orderly fashion and was not a concern at this time.

The main pad and work area was in good condition as seen in Photos Three and Four, evidence of weed management during the growing season was observed. Some areas around the perimeter of the pad area have begun to revegetate themselves with volunteer species. The whole site exhibits positive drainage and no erosional issues were observed at this time.

The overall footprint of the site was in good condition and free from excessive trash and debris. The condition of the site remains largely unchanged from the previous inspection. No problems or possible violations were noted at this time.
