

PUBLIC NOTICE

County of Fremont/Fremont County; 1170 Red Canyon Road, Cañon City, Colorado 81212; 719-276-7430, has filed an application for a Construction Materials Limited Impact (110) Reclamation Permit with the Colorado Mined Land Reclamation board under provisions of the Colorado Land Reclamation Act for the Extraction of Construction Materials. The proposed mine is known as SH69 Gravel Pit, and is located at or near Section 30, Township 19.0, Range 73.0 of the Prime Meridian.

The proposed date of commencement is July 1, 2018, and the proposed date of completion is for the life of the mine, 2033. The proposed future use of the land is to be Rangeland (RL).
