The permit was origi-nally issued by the Board in July 1981, and subsequently renewed in August 1986, January 1993 (effective August 1991), July 1996, July 2001, April 2007 (effective July 2006), and November 2011 (effective July 2011.) MCC is currently undergoing a five-year permit renewal process that would extend the permit term to July 31, 2021. The West Elk Mine five year permit area contains lands in Sections 9-11, 13-36, T13S, R90W, 6th PM; and Sections 23-26, T13S, R91W, 6th PM, and Sections 1-5 8-12, T14S, R90W, 6th PM in Delta and Gunnison Counties.
