Mr. McKinney,

Thank you for your response. The Division accepts your response to Problem numbers 1 and 3 as having been resolved.

Regarding the weed control plan, the information provided is sufficient to address weed control on site, however, Problem No. 2 required the weed control plan be submitted as a Technical Revision (TR) along with the requisite \$216 fee. Please resubmit the weed control plan as a TR. Below is a link to our technical revision form.

Finally, regarding the company name change, as you indicated on the phone "Kiewit Western Company" has been dissolved. This will require a Succession of Operator (SO) revision to the permit so that bonds, structure agreements, and legal right of entry remain valid. I am responding to your inspection report that was received on 4-5-18. Our letter responding to your inspection report is attached along with documentation of the progress we have made along with plans moving forward for Tamarisk. I found out last night was that T-P Enterprises, Inc. (the contractor to help us manage the noxious plants) came out last week to check on the foliage of the Tamarisk instead of this week like we anticipated. The leaves were not large enough yet, the plan is to wait another couple weeks before we spray. While they were there, they did cut down an Olive Tree for us so we are making progress.
