Request for Technical Revision - Supplemental Information.

McAtee Construction Company. Inc., is in the process of closing this mine and have begun to slope the mine perimeter as approved. The landowners have requested that McAtee leave a section of the current mining area for a place they can get material needed to keep their roads and farm yards maintained on their farm. We explained they could only use the material for their personal needs and not sell or give any way without having a permit. Attached is a copy of a notarized letter from Ms. Kelly Kuntz, the owner, explaining her request. I have also provided a copy of the new **Source of Legal Right to Enter** from Ms. Kuntz who obtained the property from her father, Robert Bollish.

This Technical Revision request stems from the request by the land owner to leave a small section of the current disturbed area as a landowner borrow area. This area includes the area where mining is being done, a small part of the floor for stockpile area and a road that leads from the ditch road to the borrow area. The total area covers approximately 0.47 qcres. Attached is a revised **Reclamation Plan Map** showing how the disturbed area will be reclaimed.

The remaining mined area will be reclaimed according to the approved plan, where slopes it will be graded 3:1 or less, resoiled with an average of 6 inches of dirt. Then three tons per acre of aged manure will be spread on the seed bed, tilled in and the area will be seeded with the approved seed mix.

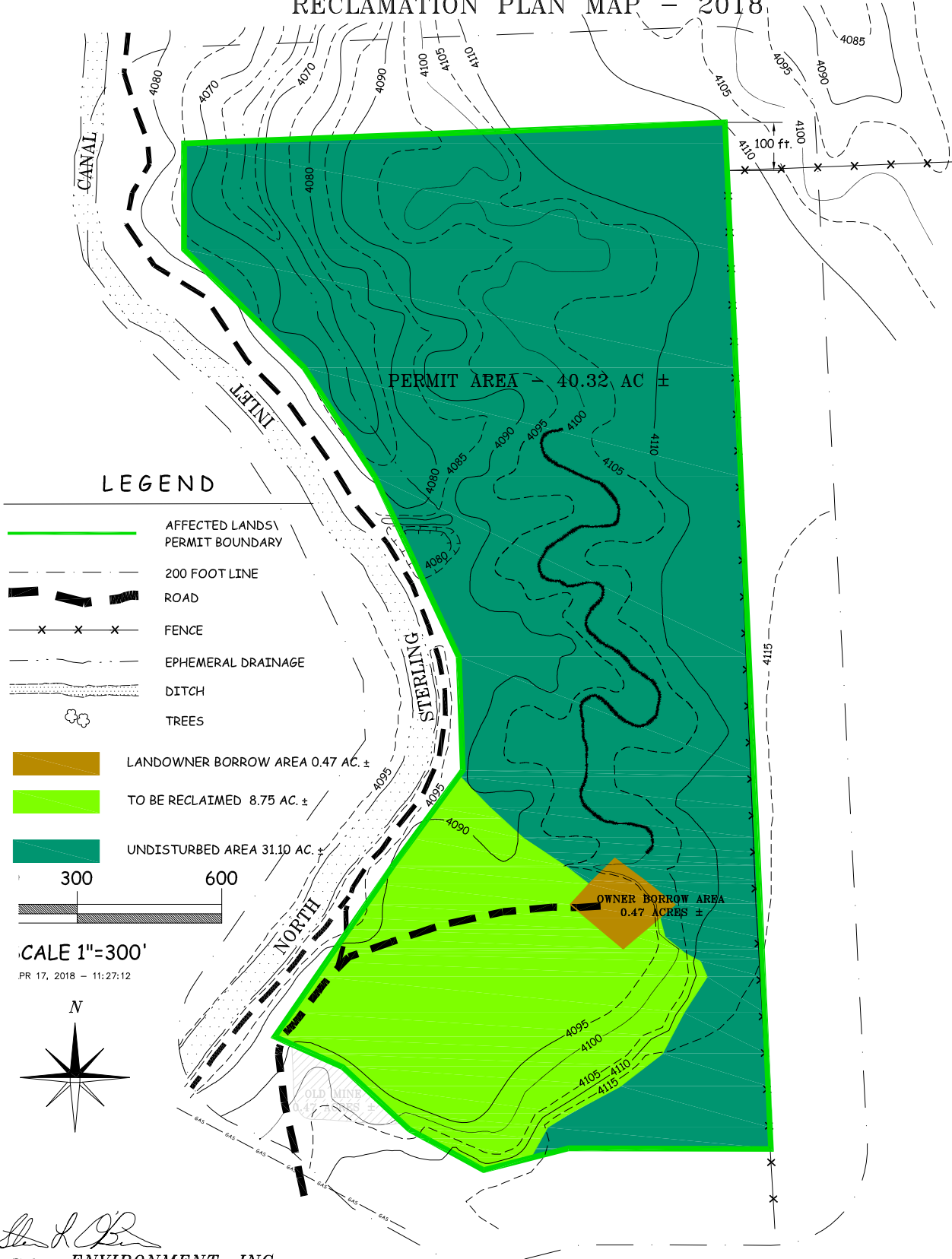



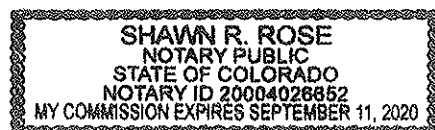
