PROBLEM/POSSIBLE VIOLATION: Problem: The mine identification sign was not posted at the entrance of the mine site. This is a problem for failure to post a mine identification sign as required by Section 3.1.12(1) of the rule.

CORRECTIVE ACTIONS: The operator shall, at the entrance of the mine site, post a sign which shall be clearly visible from the access road with the following: the name of the operator, a statement that a reclamation permit for the operation has been issued by the Colorado Mined Land Reclamation Board; and the permit number. The operator shall submit photo documentation that a proper sign has been posted by the corrective action date.

OBSERVATIONS

This inspection conducted as part of the routine inspection program established by the Division of Reclamation, Mining and Safety. The ZMK Pit is an 8.72 acre 110c gravel pit located approximately 4 miles south of Ouray Colorado. Travis Sackman of Sako Excavation, LLC and Robert Larson of Monadnock Mineral Services LLC both accompanied the DRMS during the inspection.

The mine identification sign was not posted at the entrance of the mine site. This is a problem for failure to post a mine identification sign as required by Rule 3.1.12(1). Boundary markers in the form of posts were observed around the entire perimeter of the pit.

The operation was active during the inspection. A mobile crusher was observed processing material. Various stockpiles of processed material were observed west of the crushing plant. On-highway haul trucks were observed being loaded with gravel. The overall appearance of the site appeared to be orderly and no issues other than the missing sign were observed.

The water level monitoring wells were observed. They appeared to be accessible and in properly functioning condition. Four wells are measured for water levels on a monthly basis and the results are submitted annually with the annual report.

No significant erosion within or adjacent to the mine site was observed during the inspection.
