As we spoke on April 18, 2017 I explained in detail the inability to file a formatted complaint form on the website.

I attempted to submit the form on 04/13/ 2018, 04/16/2018, 04/18/2018, at which time the internet site was unavailable and inaccessible.

You explained that the "system was experiencing glitches" and was inoperable. At this time you asked that the complaint be filed via your department email. You did not receive my formatted complaints.

ERGO:

A summary in brief of the complaints. Further details forthcoming.

1) the monitoring wells installed by Transit Mix Concrete Company/ Hitch Rack Ranch partnership in and about the Little Turkey Creek Aquifer and HHR Ditch ground source violate the intent of the permit.

The intent on permit states that the purpose is to monitor ground water through granite fractures.(see permit attached)
The three constructed wells are located in my primary ground source supply and in a strictly Alluvial aquifer and Alluvial gravel deposition. There are no granite fractures in or about my shallow well ground source supply structures.

Complaint the monitoring wells are unsecured and exposed to all avenues of contamination which may I enter my ground source, ground flow and domestic well water supplies. Attached photos current to 04/23/2018

I further complain that no care or consideration or environmental due diligence was afforded by the constuction of these monitoring systems to my only drinking water source feed.

2)As related to Jerry Snabel TM at the time of the well construction April 02, 2018, my domestic water wells could be compromised due to the disruption the gravel filter deposition beds and the various interconnective aquifer pockets convergent to on my primary water supply. WELL, , now it has happened.
The supply to my well nearest western boundary (where the TM well was constructed at a depth of 100 + feet) has become inoperable and delivery impeded.

This short synopsis serves only to file a formal complaint and ask for an inspection by appropriate parties.

This very short summary does not discount the problems caused by the operations TransitMix et al for example, domestic water wells and supply contaminated by excessive solids and constant turbidity, etc. since late summer 2016. Plumbing obstructions, installation of an R.O water filtration system became necessary in 10/2016 and never before needed during our 25 years of residency, backflushes of all systems inclusive of wells, cistern and stock tanks, hoses etc.. This at a rate of 4-6 times per annum. Previously necessary only once per 4-6 years as maintenance.

Other complaints follow.
