Tim,

For the pond liner that is outlined in green in the response to corrective actions I sent over on May 14th, our intent is to remove what is loose and not covered by vegetation by the June 19th corrective action date. We would like to not disturb any vegetation that is in the bottom of the pond or in areas where it is on top of liner at this point in time and keep the pond in place to help pull sediment out before it heads down the valley. We will of course fill and completely reclaim the pond upon closure and final reclamation in accordance with the current approved reclamation plan.

I hope this answers your question. If not I can make some time available tomorrow morning for a call to hopefully clear this up further.
