Good morning Judy,

I hope all is well. The Division cannot speak to any rumored activities which could potentially occur at the Bowie No. 1 Mine Loadout area (Loadout). As you know, the Loadout has an approved Operation Plan (C-1981-038, Volume 7 pgs 2.05.-1 through 2.05.-22) *see attached*. This Operation Plan (Plan) is the only plan that has been approved by the Division. If there is a proposed deviation from the approved Plan, Bowie Resources, LLC. will be required to submit a Revision to the Division in order to change the currently approved Plan and no changes to the currently approved Plan can occur prior to the Division's approval.

To date, the Division has not received any information proposing a change to the currently approved Plan for the Loadout.

I have heard that Bowie is going to lease the loadout area to another mine to use as a staging area. There will be multiple trucks stored there and also coming in and out of the area. This is only a rumor now--but probably true. Because Bowie has stated that the county has no jurisdiction over its use as an industrial/commercial site (per their letter to you after the county commissioners decision not to approve the salvage yard), I believe they may just start using it that way. Since this site was supposed to be for support for Bowie#2, would this be a violation of their permited use?

Again, I do not have all the facts--but if this is what they plan to do, it will have similar impact as the salvage yard would have--and no oversight.

Please let me know what would be the regulations on this---
