**Re: C & D Farms No. 2, Permit No. M-1999-043, Notice of Incomplete 110 Construction Materials Reclamation Permit Amendment Application Package, AM-1**

Dear Mr. James:

On June 12, 2018, the Division of Reclamation, Mining and Safety received your 110 Construction Materials Reclamation Permit Amendment Application package for the C & D Farms No. 2, Permit No. M-1999-043. Preliminary review of the information received determined that the following items must be received before the Division can consider your application as being submitted and technical review can begin:

**GENERAL:** The maps in the application package indicate a triangle consisting of approximately 0.6 acres is to be removed from the current permit boundary as part of this revision. The Division can only release permitted area through the Acreage Reduction (AR) process. Please submit an AR revision to be reviewed in parallel with this amendment.

**APPLICATION FORM:**

**Item 2** (p. 1) The Operation name on the amendment application "C & D Farms Pit No. 2" differs from that on the original 1999 application form "C & D Farms No. 2". Unless you wish to change the name of the operation to include "Pit", please resubmit the first page of the application using the original operation name: "C & D Farms No. 2"

**Item 11** (p. 2) The Permitting Contact was left blank. If this contact person is to be the same as the Applicant/Operator, please indicate "Same" next to the Permitting Contact.

**Item 9** (p. 3) The county name was left blank. Please resubmit p. 3 with the county name completed.

Your application will not be considered submitted until the information listed above is received and found sufficient to begin our review. A decision date will be established 30 days from the date of receipt of all of the requested information. Additionally, if you have already published notice you will need to republish notice, after the Division considers the application submitted. This notice must be published once within ten (10) days of the date your application is considered complete for the


purpose of filing. We will notify you when you should initiate publication of your notice. The final date for receiving comments is the 10th day after the publication or the next regular business day.

You have sixty (60) days from the above date to submit all necessary documents that the Office needs for an application to be considered filed. If, at the end of the sixty day period (**August 17, 2018**), the application has not been determined to be filed with the Office, the Office shall deny the application and terminate the application file.

This letter shall not be construed to mean that there are no other technical deficiencies in your application. The Division will review your application to determine whether it is adequate to meet the requirements of the Act after submittal of all required items.
