Dear Jared:

Aggregate Industries (AI) submits this letter in response to the Division's May 14, 2018 Order MV 2018-008. Corrective Action C. specified the following:

Within 60 days of the effective date of the Board's order, the Operator shall submit a Technical Revision (with notice to Fred Orr) or an Amendment to the permit to revise the Permanent Plan for the Orr property to ensure mitigation measures for the Orr property will function year round with little maintenance. Approval of such revision shall be required within the statutory time frames. Implementation of the revised Permanent Plan shall be required within thirty (30) days of approval. During the interim, the Operator shall be required to keep the Orr property sufficiently drained.

Aggregate Industries will keep the "Orr Drain" open 365 days per year effective February 16, 2018. As noted in Tetra Tech's letter report and monitoring data, submitted to the Division June 30, 2018, water levels have declined. Keeping the Orr Drain open year-round is expected to be sufficient to ensure mitigation for the Orr property on a permanent basis.

At your earliest convenience, Aggregate Industries requests that the Division conduct an inspection of the Orr property and the Orr Drain to witness the progress that has been made in addressing this issue.

Revision to operating plan to keep the Orr Drain open 365 days per year.

As defined by the Minerals Rules, a Technical Revision (TR) is: "a change in the permit or application which does not have more than a minor effect upon the approved or proposed Reclamation or Environmental Protection Plan." The Division is charged with determining if the revision as submitted meets this definition. If the Division determines that the proposed revision is beyond the scope of a TR, the Division may require the submittal of a permit amendment to make the required or desired changes to the permit.

The request for a TR is not considered "filed for review" until the appropriate fee is received by the Division (as listed below by permit type). Please submit the appropriate fee with your request to expedite the review process. After the TR is submitted with the appropriate fee, the Division will determine if it is approvable within 30 days. If the Division requires additional information to approve a TR, you will be notified of specific deficiencies that will need to be addressed. If at the end of the 30 day review period there are still outstanding deficiencies, the Division must deny the TR unless the permittee requests additional time, in writing, to provide the required information.

There is no pre-defined format for the submittal of a TR; however, it is up to the permittee to provide sufficient information to the Division to approve the TR request, including updated mining and reclamation plan maps that accurately depict the changes proposed in the requested TR.
