The Colorado Division of Reclamation, Mining and Safety proposes to approve Technical Revision Application No. 29 (TR-29) for the North Thompson Creek Mine (Permit No. C-1981-025), submitted by MINREC, Inc.. The operator requests suspension of water monitoring on North Thompson Creek upstream and downstream of the mine.
