## **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. Tom Eve and Dustin Hapl, representing the Operator, were present during this inspection. Photographs are included with this report in order to illustrate some of the conditions observed.

The Butala Pit is located approximately twelve miles west of Poncha Springs and accessed from FR 228. The site is a 110c operation that includes a total of six permitted acres. The Division currently holds a financial warranty amount of \$54,336.00 for this site. The Division has reviewed the reclamation costs in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan and determined that the current financial warranty amount is adequate.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by posts that were clearly visible and adequate to delineate the affected area boundary. During review of the permit file it was noted that the affected acreage reported in annual reports has been incorrectly reported. The annual reports from the past several years state that there are ten disturbed acres. The permit acreage is only six acres. The disturbed area is within the approved six acre permit area, as verified during this inspection. The operator is instructed to correct the error in future submittals.

This is an intermittent operation. According to the operator several loads are hauled from the site each year.

The highwall is approximately 65 feet high, spanning approximately 350 linear feet. Overburden and waste material is piled at the base of the wall.

Slopes around the mine bench are stable. No signs of excessive erosion were observed.

No problems or violations were noted during this inspection.
