## **OBSERVATIONS**

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the Operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Nicolas Pit is located approximately 6.5 miles southeast of Cimarron and accessed from CR 864. The site is a 110c operation that includes a total of 7.72 permitted acres. Because the site is operated by a county government the Division does not hold a financial warranty for this site.

Adequate mine identification signage was noted on the fence at the entrance to the site.

The affected area was marked by fencing that was clearly visible and adequate to delineate the affected area boundary.

Evidence of any recent excavation was not noted. Several small gravel stockpiles remain at the site.

Mined slopes were left at 2H:1V or less and appeared stable.

Noxious weed infestations were not observed at the site.

No problems or violations were noted during this inspection.
