OBSERVATIONS

This inspection was conducted as part of the Colorado Division of Reclamation, Mining and Safety (Division) normal monitoring program. Orvie Zimmerman represented Blue Jet Mining Inc. and accompanied Amy Yeldell of the Division and Jennifer Maiolo of the BLM on the inspection. The Blue Jet Mine is a 110(2) permitted site that includes a total of 9.9 acres in two parcels on federal lands.

This inspection was scheduled prior to the Divide wildfire, which burned nearly 20,000 acres. At the time of the inspection the wildfire was considered 100% contained and the mine had not been affected. The wildfire burned within half a mile of the mine. Site access has been intermittent due to safety road closures.

Very little mining surface disturbance remains as native vegetation has volunteered. The site is very green despite the poor winter. No weeds were observed. The site will likely be heavily grazed by wildlife given the water source and close proximity to the fire.

No equipment, fuel structures or other debris is on site. Mr. Zimmerman indicated that he excavated a large batch sample earlier this year. No stockpiles are present and slopes appear to be stable.

The Division holds a bond in the amount of \$3,132.
