OBSERVATIONS

This inspection was conducted as part of the normal monitoring program established by the Colorado Division of Reclamation Mining and Safety. The North Amethyst West Project is a 2.44 acre prospecting drilling project. Rio Grande Silver, Inc. mine manager Randy McClure was present during the inspection.

All drilling locations associated with this NOI observed during this inspection are in final reclamation. The grading completed ties in extremely well with the adjacent non disturbed lands. Vegetation will likely be established enough within the next 1-3 growing seasons to be considered releasable.

No erosion or sedimentation issues were noted. There are no major or minor drainage issues within the prospect area that warrant addressing.
