AFFIDAVIT OF DON SUMMERS, TODD CREEK VILLAGE METROPOLITAN DISTRICT, DEDICATING WATER RIGHTS TO THE SIGNAL RESERVOIR NO. 1 SUBSTITUTE WATER SUPPLY PLAN

I, Don Summers, being of legal age and being first duly sworn, state upon oath as follows:

1. I am the Secretary of the Board of Directors of Todd Creek Village Metropolitan District ("Todd Creek"), a quasi-municipal corporation and political subdivision of the State of Colorado organized under Title 32 of the Colorado Revised Statutes.

 As Secretary of the Board of Directors of Todd Creek, one of my responsibilities is to oversee capital projects for the district, including the enlargement of Signal Reservoir No. 1 (WDID 0203939).

Todd Creek is seeking a permit from the state Division of Reclamation, Mining and Safety ("DRMS") to perform excavation work for the enlargement of Signal Reservoir No.
1.

4. As part of Todd Creek's portfolio of water rights, Todd Creek has the perpetual right to divert, use, and reuse to extinction 500 acre-feet of fully-consumable effluent per year under an April 30, 2004 Amended and Restated Raw Water Service Agreement with Consolidated Mutual Water Company ("ConMutual"). Todd Creek holds the right to 200 acre-feet per year of said contract rights, with the remaining 300 acre-feet per year held by H3O, LLC, which has granted permission in writing for Todd Creek to use its portion of the ConMutual water as a replacement source under Todd Creek's plan for augmentation decreed in Case No. 13CW3181. The sources of ConMutual's rights to the fully-consumable effluent under the Raw Water Service Agreement include, but are not limited to, the decrees entered in Case Nos. 94CW197, dated October 20, 1997, 01CW56, dated January 27, 2006, 02CW226, dated

February 21, 2006, 09CW107, dated January 21, 2013, and 13CW17, dated July 26, 2016, all in Water Division No. 1. The water supplied under the ConMutual agreement is fully consumable and is decreed for all beneficial uses, including augmentation. ConMutual's reusable effluent is discharged to the South Platte River from Metro Wastewater Reclamation District's Robert W. Hite sewage treatment plant outfall, located on the east bank of the South Platte River at a point near the section line between Sections 1 and 12, T.3S., R.68W., 6th P.M., Adams County, Colorado.

5. The quantity of groundwater projected to be depleted through evaporation as a result of excavation work at the Signal Reservoir No. 1 enlargement totals 111 acre-feet per year, as shown in the July 30, 2018 memorandum prepared by Gina Burke, attached hereto as **Exhibit**

<u>A</u>.

6. Todd Creek submitted an application for a Substitute Water Supply Plan ("SWSP") to the state Division of Water Resources on June 21, 2018. The application is pending.

7. Todd Creek will retain ownership and control of the ConMutual water rights for as long as replacement of the evaporative depletions is necessary or until Todd Creek obtains another replacement source. Said water rights will not be sold or traded to others during the term of this dedication.
