# **INSPECTION TOPIC:** Hydrologic Balance

**PROBLEM/POSSIBLE VIOLATION:** Problem: Erosion gullies and ruts were observed on-site. This is a problem at this time for failure to protect the affected land from erosion pursuant to C.R.S. 34-32.5-116 (4) (j). Current mine bench configuration allows for capture and transport of surface water through mine working.

**CORRECTIVE ACTIONS:** The operator shall provide photo documentation to the Division verifying erosion gullies and ruts have been repaired, and that the site has been reconstructed and stabilized to prevent erosion damage by the corrective action date. Submittal of a technical revision to address the mine bench configuration to prevent hydrologic issues.

### **OBSERVATIONS**

This inspection was conducted as part of the normal monitoring program established by the Colorado Division of Reclamation Mining and Safety. The Ruby Trust Mine Operation is an active 110(2) underground mine. The commodities mined are gold and silver. The mine currently consists of 2.0 permitted acres. The Ruby Trust Mine operation is located approximately 6 miles west of Ouray Colorado up Yankee Boy Basin Road. Mine representative Bob Larson was present during the inspection.

The mine identification sign was observed at the entrance to the mine site and is in compliance with Rule 3.1.12.

The mine was not active during the inspection. Evidence of a recent major precipitation event was observed at the main access and working bench of the mine site. The precipitation surface flow entered the mine from the north side from a drainage up-gradient of the mine bench. Bob Larson stated that he plans to get an excavation contractor on site as soon as one is available to fix the erosional issues. This is seen as a problem and the operator is required to provide photo-documentation that the erosional issues have been repaired no later than September 7, 2018.

Mr. Larson pointed out to the inspector that the current configuration of the mine tunnel entrance was altered by the previous operator. The alteration is problematic due to its ability to allow surface water into the original mine entrance and then flowing out of a lower mine entrance. This is also seen as a problem that must be corrected. A technical revision to address the configuration and water capturing issues must also be submitted no later than September 7, 2018.

Various excavation and hauling equipment was observed throughout the mine site. The mine site was somewhat disorganized and various pieces of scrap material and defunct mining equipment was observed. This is not seen as a problem at this time and seems to be more of a lack of good "housekeeping".
