OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Gold Basin Mine is located approximately five miles west of Granite and accessed from CR 398. The site is a 112 operation that includes a total of 32.30 permitted acres. The Division currently holds a financial warranty amount of \$12,500.00 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is adequate.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by posts that were clearly visible and adequate to delineate the affected area boundary.

The operation is located in the headwater of the Cache Creek drainage, in an area heavily disturbed by historic mining operations. Topsoil from historic mining was not salvaged, so therefore there is no topsoil stockpiled on site. Most of the mined slopes throughout the permit area are left at the angle of repose, roughly 1H:1V.

Mining at this site occurs intermittently on a very small scale. Currently, operations are placed in an area below the building. There is a sluice set-up and two small wash ponds. Water for the ponds appears to be pumped from Cache Creek. It does not appear that water is discharged from the ponds.

The lower pond area, the previous location of the sluice, has been filled in and graded flat.

There is a large tank labeled "waste oil" near the entrance to the site. It is unclear if the tank is currently used for waste oil storage or not, but the tank is not in secondary containment and there does appear to be at least some fuel or oil in the tank. The tank should be removed from the site and the contents properly disposed of at an authorized hazardous waste facility.

No other problems or violations were noted during this inspection.
