## Re: <u>Permit No. M-1980-244; Cripple Creek & Victor Gold Mining Company ("CC&V"); Cresson Project</u> - <u>Notification of Water Quality Analysis Parameter Exceedances August 21, 2018</u>

Dear Mrs. Eschberger:

In accordance with Rule 9, Section 3.1.7 of the Mineral Rules and Regulations of the Colorado Mined Land Reclamation Board for Hard Rock, Metal, and Designated Mining Operations (Rules), the Cripple Creek and Victor Gold Mining Company (CC&V) hereby provides the Division of Reclamation, Mining and Safety (Division) with formal notification of water quality parameter exceedances.

CC&V collected third quarter compliance groundwater and surface water monitoring water quality samples for analysis on July 30<sup>th</sup>, 31<sup>st</sup>, and August 1<sup>st</sup>. CC&V received the lab report for these analyses on August 17, 2018, and upon review, some locations exceeded established numeric protection limits. The table below lists the exceedances for each location and the associated parameters, and the attached graphs demonstrate parameter trends from Q1 2017 to present.
