OBSERVATIONS

This inspection was conducted as part of the Colorado Division of Reclamation, Mining and Safety normal monitoring program. The Bunn Ranch Pit is a 112c permitted site that includes a total of 133 permitted acres with a max disturbance of 50 acres. Tanner Brown represented Elam Construction, Inc. and accompanied Amy Yeldell of the Division on the inspection.

No new reclamation or excavations have occurred since the last inspection. This pit is primarily used for material stockpiling. The pit was active at the time of the inspection. A significant amount of hauling was observed, several trucks were lined up to be loaded. There were several large stockpiles of various material types neatly stored. No material is being excavated from the Bunn Ranch Pit at this time. All new material is being imported is from the adjacent Gehrman Pit (M-2009-078) and others. Material imported from the Gehrman Pit is processed onsite at the Bunn Ranch. Both the wash plant and asphalt hot plant were in operation at the time of the inspection. Several fuel tanks throughout the mine remain in secondary containment structures or are double walled tanks. The scale, scale house and office remain on site and in use.

The mined out portions of this site consists of several large mostly reclaimed ponds. The majority of them have proper sloping and are stabilized well with native vegetation. The operator is encouraged to finish sloping and complete reclamation in areas that won't interfere with their day to day operations.

No problems were noted during this inspection.

The Division currently holds a financial warranty amount of \$178,600 for this site. The bond was last calculated in 2015. In an effort to ensure the Financial Warranty adequately, reflects the actual current cost of fulfilling the requirements of the approved reclamation plan the Division will be updating the reclamation cost estimate. You will be notified if the current bond is found insufficient. A copy of the staff calculations will be sent under separate cover.
