OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. Representatives from D.O.E. were present. Gus Gaviotis and Scott Pottorfs, representing Cotter Corporation, were present. Photographs are included with this report in order to illustrate some of the conditions observed.

The SM-18 Mine is located northeast of the Uravan town site and accessed from U17 Road. The site is a 112d operation that includes a total of 14.9 permitted acres.

Adequate mine identification signage was noted at the entrance to the site.

The south portion of the affected area consists of the Wright Portal, an operations area, sediment control structures, and ore and waste rock areas. Cleanup around the office trailer in the operations area has occurred. The broken windows have been boarded up. Sediment control features are maintained and appear to be functioning as designed. No problems related to erosion or sedimentation were noted.

The north portion of the affected area, on the north side of Spring Camp Mesa, consists of the old reclaimed portal and mine area. A steel building is located in this area. The building appears in good repair. Vegetation is well established over the reclaimed waste rock pile.

The hoist assembly has been removed from the venthole area. The fan is still securely in place over the venthole. No problems were noted in this area.

No problems or violations were noted during this inspection.
