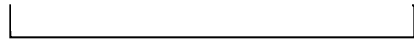

**PUBLIC NOTICE**

North Weld County Water District, 32825 CR 39, Lucerne, Colorado 80646; (970) 356-3020, has filed an application for a Regular (112) Construction Materials Operation Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Land Reclamation Act for the extraction of construction materials. The proposed operation is known as Lamb Lakes and is located in or near Section 3, Township 7 North, Range 69 West of the 6th Prime Meridian, Larimer County, Colorado. The general location of this operation is about one (1) mile north of the City of Fort Collins, Colorado and approximately 0.5 miles east of North Taft Hill Road.

The proposed date of commencement for operations included in the permit area is 2018 and the proposed date of completion is 2029. The proposed future use of the land is developed water storage.
