SUBJECT: Planning Review: Re. No Impact Technical Revision (Appendix A - 8.B) of Cripple Creek and Victor Gold Mining (CCV) Permit No. M-1980-244; Cripple Creek & Victor Gold Mining Company; Cresson Project; - TR-#106 Ready Line Construction

Dear Ms. Burt:

The Teller County Planning Department has completed its review of the Newmont Mining Corporation's (CC&V) Technical Revision TR # 106 – Ready Line Construction.


1. Teller County understands that this TR is being submitted to DRMS in order to construct a new ready line for mine operations equipment to be located immediately to the west of the East Cresson Overburden Storage Area (ECOSA) as depicted in figure 1 of the TR request.
2. It is further understood that this change is due to removal of overburden material which lies underneath and in the vicinity of the current ready line. Once removed, the approximately 1.5 million tons of overburden material from the Globe Hill and Schist Island pits, will be placed directly to the west of the current ECOSA footprint as depicted on page 2 of the included figure 1. This material will be placed at a height not to exceed 10, 680 feet.
3. Both the current ready line and the new ready line, as well as the current location of the overburden material and the new location of the overburden material lie within the CCMOD. Finally, if approved, this activity will begin on October 1, 2018 and weather depending, should be complete by the end of October 2018.
4. Pursuant to follow on information received from Katie Blake, Senior Environmental Coordinator CC&V on September 20, 2018, there will be no additional internal roads created, no vaults or septic systems and no additional structures requested or built as a result of the movement of the ready line.

5. Teller County has reviewed this request against the standards contained in Appendix A, CCMOD, sections 8.A and 8.B and finds that it is compliant. Teller County concurs with TR# 106 as written and has no objections subject to two conditions of approval:

- a. That the new overburden storage area which will lie directly to the west of the existing ECOSA area as depicted in figure 2 of the TR request not exceed the 10,680 foot height.
- b. That the new overburden storage area which will lie directly to the west of the existing ECOSA area as depicted in figure 2 of the TR request not include any lighting.
