In accordance with Condition of Approval No. 1, you have provided a signed agreement with William M. Blatchley of North Fork Associates, LLC to extend the lease with North Fork Associates, LLC and Mountain Mutual Reservoir Company for the lease of an annual amount of 28.0 acre-feet of replacement water, with the option of leasing an additional 10.0 acre-feet, for a second one-year period terminating October 31, 2019. The original SWSP was approved on June 19, 2017 for operations beginning June 19, 2017. Therefore, this substitute water supply plan is extended through May 31, 2019.
